**ICANN's 2013 RAA Outreach in Berlin, Germany**

**Expired Registration Recovery Policy in Effect**

Since 1 September 2013, ICANN received and processed 40 domain renewal complaints to ensure compliance with the new ERRP requirements (<http://www.icann.org/en/resources/registrars/consensus-policies/errp>). Thirty of the submitted complaints were addressed and closed; the remaining 10 complaints are being addressed thru the compliance process. There were 123 web views for the FAQ about ERRP. **Bulk Whois Inaccuracy Complaint Submission Pilot Update**

On 24 September 2013, the bulk submission tool received a total of 78 Whois Inaccuracy complaints in one submission. The complaints are still in the compliance process.

The Contractual Compliance team is finalizing the process, frequently asked questions, notifications and communication templates to accommodate the receipt of complaints to support four new Dispute Resolution Procedures: (1)

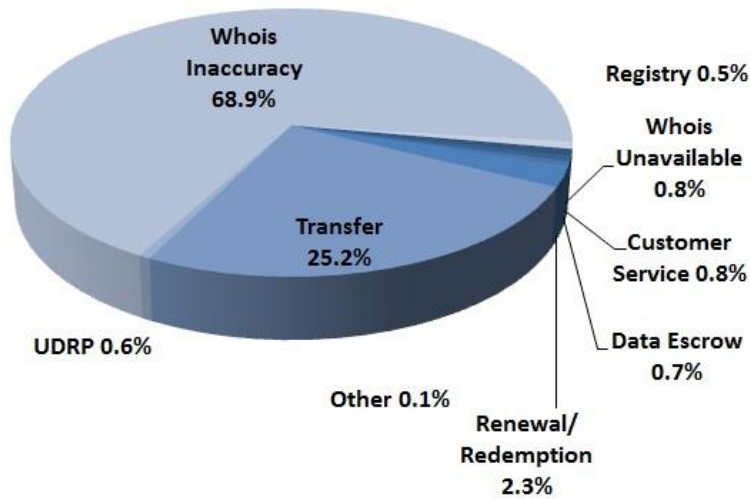

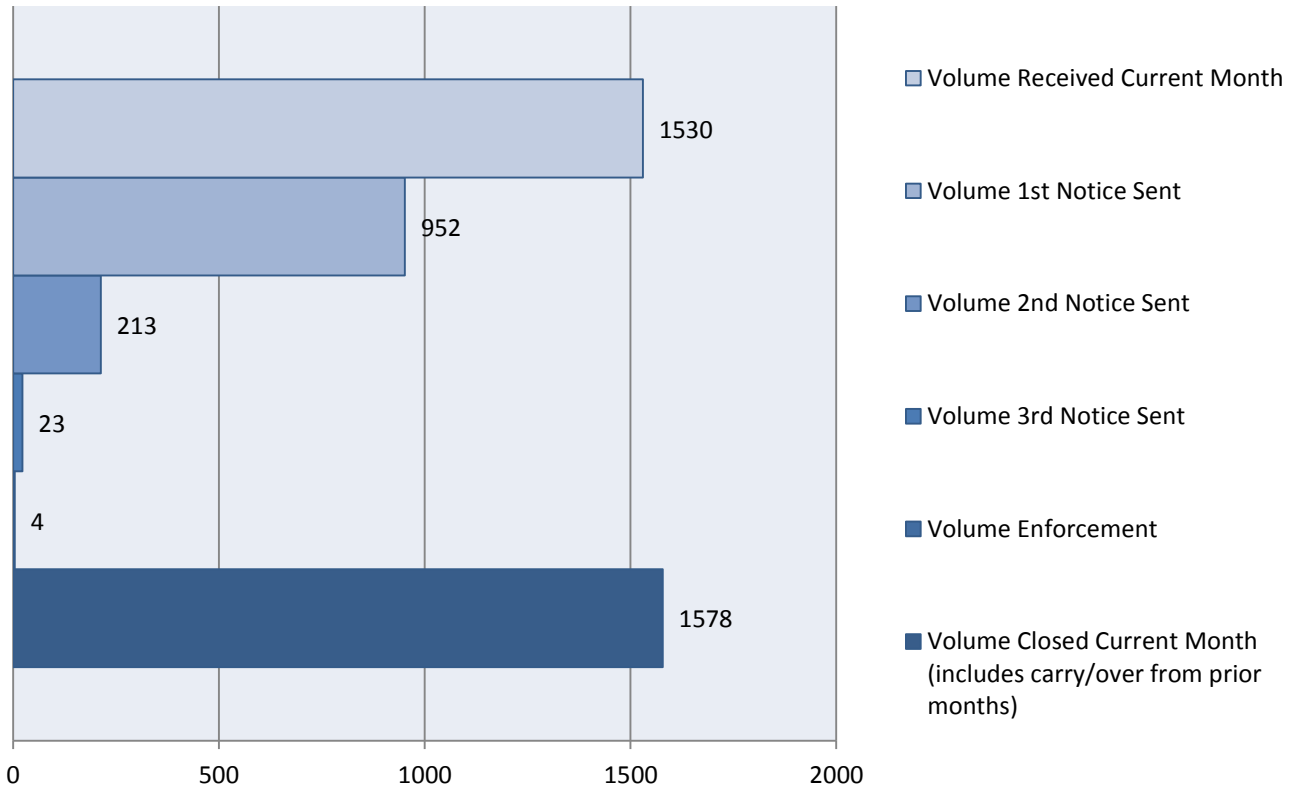
