Section III: Summary of Comments

The New gTLD Subsequent Procedures Policy Development Process (PDP) Working Group sought community input on approximately forty topics. Within those topics the Working Group has drafted over two hundred outputs, of which there are five types: (a) Affirmation, (b) Affirmation with Modification, (c) Recommendation, (d) Implementation Guidance, and/or (e) No Agreement. The types of outputs are described on page four of the draft Final Report. The Working Group is appreciative of the level of input received on the outputs, not just in terms of volume, but the degree of thought and consideration that has gone into the drafting of the comments.

Given the breadth of areas in which the Working Group sought feedback, it is not practical to capture every theme of feedback provided on this report. The Working Group is committed to reviewing each and every single comment and it is their responsibility to determine the level of impact, if any, on any final outputs and/or Final Report.

Section IV: Analysis of Comments

<u>General Disclaimer</u>: This section is intended to provide an analysis and evaluation of the comments received along with explanations regarding the basis for any recommendations provided within the analysis.

The PDP Working Group received a substantial amount of input on its draft outputs and intends to review each comment to determine what effect it may have, if any, on final outputs and the Final Report.

This Report of Public Comments does not seek to draw any conclusions from the Public Comment as that is the sole remit of the PDP Working Group, and the Working Group has only begun its review of comments at this stage. Working Group members will have to assess the arguments brought forward and integrate them into their Final Report as appropriate.

Given that there have been numerous opportunities for the community to comment on the PDP's work over the last four years, respondents were asked to focus their input during this Public Comment period on new information or positions that that the Working Group has not previously considered along with an explanation and/or supporting documentation describing why the Working Group's proposed outcome should be different. In conducting the initial organization of comments to produce the Public Comment review working documents, staff took note of the distribution of substantive comments across the different topics included in the draft Final Report. This initial examination will help the Working Group organize its work plan for analyzing the inputs received and discussing any potential changes.

Staff notes that for a number of topics included within the draft Final Report, a significant set of groups and individuals expressed support for, acceptance of, or no opinion on the draft outputs and only a limited set of new ideas and concerns was raised. Examples of such topics include:

- Topic 5: Application Submission Limits
- Topic 8: Conflicts of Interest

- Topic 19: Application Queuing
- Topic 22: Registrant Protections
- Topic 26: Security and Stability
- Topic 28: Role of Application Comment
- Topic 29: Name Collisions
- Topic 32: Limited Challenge / Appeal Mechanism
- Topic 33: Dispute Resolution Procedures After Delegation
- Topic 37: Registrar Non-Discrimination & Registry/Registrar Standardization
- Topic 38: Registrar Support for New gTLDs
- Topic 39: Registry System Testing
- Topic 40: TLD Rollout

This may provide an initial indication that a greater share of the Working Group's attention should be devoted to the remaining topics for which a more substantial set of new ideas and concerns has been provided, for example: Topic 2: Predictability, Topic 9: Registry Voluntary Commitments/Public Interest Commitments, Topic 17: Applicant Support, Topic 20: Application Change Requests, Topic 23: Closed Generics, Topic 32: Limited Challenge/Appeals Mechanism, Topic 34: Community Applications, and Topic 35: Auctions: Mechanism of Last Resort / Private Resolution of Contention Sets. For the avoidance of doubt, the Working Group will carefully consider all comments on all topics, including comments and questions that ICANN org and Board have submitted raising new considerations for the Working Group to take into account on some of the above listed topics.
