.BBC Launch Policy

This .BBC Launch Policy sets out the policies to be followed during the initial launch phased for the .BBC Top Level Domain.

Any domain name registered during the initial launch phased of the .BBC Top Level Domain are subject at all times to the .BBC Domain Name Registration Policy (the “**.BBC Domain Policy**”) which can be found at nic.bbc/policy.

General/Definitions

Terms used in this .BBC Launch Policy that are not defined below have the same meaning as in the .BBC Domain Policy. Additional terms specific to this .BBC Launch Policy include:

Identical Match means that the domain name consists of the complete and Identical textual elements of a Clearinghouse-validated trademark. In this regard: (a) spaces contained within a mark that are either replaced by hyphens (and vice versa) or omitted; (b) only certain special characters contained within a trademark are spelled out with appropriate words describing it (“@” and “&”); (c) punctuation or special characters contained within a mark that are unable to be used in a second-level domain name may either be (i) omitted or (ii) replaced by a hyphen and still be considered Identical matches; and (d) no plural or “marks contained” (i.e., “brandx” in “brandxproducts”) qualify for inclusion.

Sunrise means an opportunity for trademark owners to register the exact Identical Match of their mark as a domain name prior to general domain name availability in the .BBC Top Level Domain; any Sunrise registrations in the .BBC Top Level Domain are subject to eligibility criteria.

Trademark Claims means notice to a prospective domain name registrant of the scope of the mark holder’s rights whereby the prospective registrant warrants that: (i) they have received notification that the mark(s) is included in the Clearinghouse; (ii) they have received and understood the notice; and (iii) to the best of their knowledge, the registration and use of the requested domain name will not infringe on the rights that are the subject of the notice. If the domain name is registered subsequent to the notice being issued and the registrant attesting to its non-infringement, the Registrar or the Clearinghouse will notify the mark holders(s) of the registration.

Trademark Clearinghouse means a central storage repository of validated (authenticated) trademark rights-related data and information for dissemination with respect to trademark rights protection mechanisms and other registry-related services.

Terms used in the singular or plural are merely for convenience, and shall apply mutatis mutandis, as the context may require.

All communications and information under this .BBC Domain Policy shall be in English.

Sunrise Policy

The .BBC Sunrise will last for thirty (30) calendar days.

For purposes of the .BBC Sunrise, BBC will recognise and honour all Clearinghouse-validated word marks:

- (i) nationally or regionally registered and for which proof of use – which can be a declaration and a single specimen of current use – was submitted to, and validated by, the Trademark Clearinghouse; or
- (ii) that have been court-validated; or
- (iii) that are specifically protected by a statute or treaty currently in effect and that was in effect on or before 26 June 2008.

Only applicants who are eligible under the terms of the .BBC Domain Policy may submit a request for registration of a .BBC domain name under the .BBC Sunrise.

Any request for registration of a .BBC domain name by an ineligible applicant will be rejected without notice.

Upon submission of a signed mark data (SMD) file, containing a Trademark Clearinghouse-validated record to the Registrar, and the Registrar's confirmation to BBC that a domain name is available for registration, any request for registration of a .BBC domain name under the .BBC Sunrise will be processed in accordance with the terms of the .BBC Domain Policy.

Sunrise Dispute Resolution Policy

The .BBC Sunrise Dispute Resolution Policy (SDRP) will allow challenges to Sunrise registrations undertaken pursuant to the .BBC Sunrise Policy, on the following grounds:

- (i) at time the challenged domain name was registered, the registrant did not hold a trademark registration of national effect (or regional effect) or the trademark had not been court-validated or protected by statute or treaty;
- (ii) the domain name is not identical to the mark on which the registrant based its Sunrise registration;
- (iii) the trademark registration on which the registrant based its Sunrise registration is not of national effect (or regional effect) or the trademark had not been court-validated or protected by statute or treaty; or
- (iv) the trademark registration on which the domain name registrant based its Sunrise registration did not issue on or before the effective date of the .BBC Registry Agreement and was not applied for on or before ICANN announced the new gTLD applications received.

Any SDRP challenge should be submitted to [REDACTED]

The merits of any SDRP challenge will be determined by the .BBC Domain Team including with its agents and/or advisors.

Upon receipt of a SDRP challenge determination, the implementation of any SDRP determination will be managed by BBC in its sole discretion, in accordance with the .BBC Domain Policy.

Trademark Claims

For purposes of .BBC Trademark Claims BBC will recognise and honour all word marks that have been or are:

- (i) nationally or regionally registered;
- (ii) court-validated; or
- (iii) specifically protected by a statute or treaty in effect at the time the mark is submitted to the Clearinghouse for inclusion – for purposes of Trademark Claims no demonstration of use is required.

The Registrar will provide notice to trademark owners whose marks have been validated by the Clearinghouse where a .BBC registration which is an exact Identical Match to their trademark is registered during the .BBC Sunrise and for the first 90 days (the “**Trademark Claims Period**”) after the .BBC Top Level Domain is open for general registration.

During the Trademark Claims Period, an attempt to register a domain name that is an Identical Match to a Clearinghouse-validated mark will trigger a Trademark Claims Notice (see Annex). Upon a registrant’s confirmation that they have received and understand Trademark Claims Notice, and that to the best of their knowledge the registration and use of the requested domain name will not infringe the trademark rights listed in the Trademark Claims Notice, a request for registration will be managed by BBC in accordance with the .BBC Domain Policy.

If, pursuant to the .BBC Domain Policy, a request to register a .BBC domain name which is an Identical Match to a Clearinghouse-validated mark is eligible and subsequently registered, BBC or the Registrar will notify the relevant mark holders(s) of the registration.

.BBC Domain Name Registration Policy

The only remedy in case of any disagreement with the current terms of the .BBC Domain Policy is to cancel the requested domain name registration.

The terms of the .BBC Domain Policy as described below constitute the entire agreement concerning the registration of a .BBC domain name; no other agreements or representations supplement or alter the terms of the .BBC Domain Policy, except as expressly incorporated herein.

General/Definitions

Abuse Point of Contact means the .BBC Top Level Domain’s abuse response team, which can be contacted at [REDACTED]

BBC (or “we” or “us”) means British Broadcasting Corporation.

.BBC means the .BBC Top Level Domain.

.BBC Domain Policy the .BBC Domain Name Registration Policy which sets out the terms and conditions governing the registration and use of domain names in the .BBC Top Level Domain.

Registrar means the entity through which a .BBC domain name registration is undertaken

Registry Services Provider means the entity providing back-end technical and operational services for the .BBC Registry.

Top Level Domain means the final characters after the dot in a domain name; in the case of “nic.bbc”, this is “bbc”.

You or your means an individual or entity seeking to initiate registration of a .BBC domain name, or if allowed, the domain name registrant.

Terms used in the singular or plural are merely for convenience, and shall apply mutatis mutandis, as the context may require.

All communications and information under this .BBC Domain Policy shall be in English.

Registration Eligibility

Eligibility to register or use a .BBC domain name (including controlling associated DNS records) is limited to BBC, and upon the BBC’s sole discretion its Affiliates or Trademark Licensees.

The terms “Affiliates” and “Trademark Licensees” are defined and used in the .BBC Domain Policy as it is in the ICANN Registry Agreement applicable to the .BBC Top Level Domain, available at www.icann.org/en/about/agreements/registries/bbc.

BBC reserves the right, for any reason, to periodically verify .BBC domain name registration eligibility. Any determination as to such eligibility shall be made by BBC in its sole discretion, and is not subject to any further appeal mechanism or reconsideration process. BBC reserves the right, in its sole discretion, to suspend, cancel, revoke, or take other action it deems necessary with respect to a .BBC domain name registrant in the event it determines that their registration violates the registration eligibility criteria. Questions about a determination by BBC as to .BBC domain name registration eligibility should be directed to the Abuse Point of Contact.

To assist in ensuring compliance with the .BBC Domain Policy, “privacy” or “proxy” registrations may not be permitted in the .BBC Top Level Domain.

- you agree that for certain aspects of the management of the .BBC Top Level Domain, for example a rapid takedown process, BBC may delegate certain functions to an agent such as its registry services provider
- you agree to the applicability of ICANN-mandated Rights Protection Mechanisms, including

Domain name registrations in the .BBC Top Level Domain follow a four-step process managed by BBC or its Registrar or agent: (i) Eligibility Confirmation; (ii) Naming Convention Check; (iii) Acceptable Use Review; (iv) Registration.

.BBC domain name registrations are available to eligible registrants for annual terms between one (1) and ten (10) years.

In the event Internationalized Domain Name (IDN) registrations are made available in the .BBC Top Level Domain, they will be subject to the .BBC IDN registration pairing rules as and when they are developed.

(i) Eligibility Confirmation

Only BBC, BBC's Affiliates, or Trademark Licensees who agree to be bound by the terms of the .BBC Domain Policy are eligible to register or use a .BBC domain name. .BBC domain names may not under any circumstances be registered or used by third parties other than BBC, BBC's Affiliates, or Trademark Licensees.

Prior to any .BBC domain name registration or renewal, and at any time during the registration life cycle, domain name registrations will be verified by BBC for compliance with the .BBC Domain Policy including as to eligibility.

(ii) Naming Convention Check

.BBC domain names must meet the following technical conditions:

- a. must be at least 1 character and no more than 63 characters long
- b. must contain only letters (a-z), numbers (0-9) and hyphens or a combination of these
- c. must start and end with an alphanumeric character, not a hyphen
- d. must not be a Reserved Name
- e. domain names at the second level, must not contain a hyphen at the 3rd and 4th positions (tagged domains), unless corresponding to a valid Internationalized Domain Name in ASCII encoding (for example "xn--ndk061n").

(iii) Acceptable Use Review

By asking us to register or renew a .BBC domain name registration, you warrant and represent that the requested .BBC domain name registration does and will at all times comply with the .BBC Domain Policy.

Registration or renewal of a .BBC domain name is subject to BBC's satisfaction that the Acceptable Use standards set out below are met prior to, and at all times during, a .BBC domain name registration.

(iv) Registration

Provided that the .BBC eligibility confirmation, naming convention check, and acceptable use review are satisfied, and any fees paid, BBC will provide a secure instruction per its internal domain management process to the Registrar to proceed with the registration or renewal of the requested .BBC domain name.

If at any point prior to the registration expiration date you no longer wish to maintain the requested .BBC domain name registration, you may submit a written request by email to BBC at [REDACTED] and the Registrar requesting cancellation of the applicable registration. Please note that if you

cancel a .BBC domain name registration, BBC is under no obligation to make that domain name available for future registration.

At the conclusion of the registration period for the requested .BBC domain name, unless you have instructed the Registrar (with a copy to us) otherwise prior to the expiration of the requested .BBC domain name registration, the Registrar will renew the requested .BBC domain name registration on the basis of an agreed standing renewal order; in the event the requested .BBC domain name registration is renewed, the Registrar will collect any applicable renewal fees.

Acceptable Use

BBC reserves the right to periodically review .BBC domain name registrations and uses for compliance with the .BBC Domain Policy. For example, but without limitation, by registering a .BBC domain name, or by asking us to maintain or renew a .BBC domain name registration:

- you represent and warrant that you will not distribute malware or operate botnets, or engage in phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or any other activity contrary to applicable law
- you acknowledge and agree that it is your responsibility to determine whether the requested domain name registration does or may infringe or violate the rights of a third party or applicable law
- you warrant and represent that your registration or use of a .BBC domain name does not and will not:
 - give rise to any morally objectionable or otherwise socially questionable conduct
 - violate any applicable laws or regulations
 - in any way harm the reputation or goals and operating principles of BBC

You further agree that BBC may, in its sole discretion, lock, suspend, cancel, revoke, or otherwise take (or require you to take) remedial action to cure any breach of the .BBC Domain Policy if the registration or use of a .BBC domain name violates the .BBC Domain Policy or applicable law, or otherwise violates standards of conduct deemed acceptable to BBC in its sole discretion.

By registering a .BBC domain name, or by asking us to maintain or renew a .BBC domain name registration, you agree to follow the BBC's domain registration conventions and policies which may, in the BBC's sole discretion, be updated from time to time.

Any failure to comply with these acceptable use standards may be considered a breach of the .BBC Domain Policy and may, in BBC's sole discretion, be grounds for the suspension, cancellation, or revocation of the requested .BBC domain name registration.

Reserved Names

The following terms are reserved from registration by third parties:

- a. reserved terms prohibited by ICANN from availability for registration including as provided in the ICANN Registry Agreement applicable to the .BBC Top Level Domain, and in particular:

1. the terms “example”, “www”, “rdds”, and “whois” at all levels, which at BBC’s sole discretion shall be withheld from registration or allocated to BBC
 2. the term “nic”, at all levels, as this term shall be allocated to BBC for use in connection with the operation of the .BBC Top Level Domain;
- b. any term reserved by BBC from time to time at its sole discretion.

Abuse Prevention and Mitigation

BBC will not tolerate abusive or malicious conduct (including, but not limited to: illegal or fraudulent actions, spam, phishing, pharming, distribution of malware, malicious fast flux hosting, botnets, distribution of illegal child sexual images, online sale or distribution of illegal pharmaceuticals) in the .BBC Top Level Domain. In addition to any monitoring BBC may undertake to prevent abusive or malicious conduct, BBC has established an abuse point of contact for handling complaints or concerns related to any such conduct, which shall also include investigation of and a response to any reports from law enforcement and governmental and quasi-governmental agencies of illegal conduct in connection with the use of the .BBC Top Level Domain. In the event of a complaint or information from a law enforcement agency, BBC will acknowledge the receipt of such complaint or information within 24 hours.

In furtherance of BBC’s efforts aimed at abuse prevention and mitigation, or where it appears that a .BBC domain name is being used to threaten the stability or security of the .BBC Top Level Domain or is a part of a real-time investigation by law enforcement, BBC may, either on its own initiative or based on information provided by a third party where appropriate and in the BBC’s discretion, initiate a threat mitigation process.

In the event of any suspected abusive or malicious conduct or violation of the .BBC Domain Policy or any applicable laws, BBC may suspend or lock the requested domain name registration pending resolution of any such suspected violation.

In the event a threat mitigation process is initiated, after any assessment by BBC, the Registrar may be contacted for its cooperation in taking the subject domain name down (by locking or suspending the domain name, or placing it on hold or deleting it), unless a compelling argument is provided by the Registrar to BBC on which basis the subject domain name may remain in the zone. In either event, if the Registrar has not reacted within 24 hours of BBC’s request, BBC may place the subject domain name on “ServerHold” or any other status it deems necessary or appropriate. If BBC determines that the subject domain name is being used to threaten the stability or security of the .BBC Top Level Domain or is a part of a real-time investigation by law enforcement, BBC reserves the right to immediately remove the subject domain name from the zone, in which case BBC will inform the Registrar of such action being taken.

While respecting privacy and confidentiality, BBC may periodically conduct technical analyses to assess whether domain names in the .BBC Top Level Domain are being used to perpetrate security threats, such as pharming, phishing, malware, or botnets. If BBC identifies security risks that pose an actual risk of harm, it will notify the Registrar and, if the registrar does not take immediate action, BBC may suspend the domain name until the matter is resolved.

BBC or its delegate may remove orphan glue records (see www.icann.org/en/committees/security/sac048.pdf) when provided with written evidence that such records are present in connection with malicious conduct.

Abuse Point of Contact

Inquiries, whether from law enforcement or the general public, related to alleged abusive or malicious conduct in the .BBC Top Level Domain should be directed to the .BBC Abuse Point of Contact. Complaints may also concern Whois information accuracy, or concerns that a domain name registration is being used to facilitate or promote malware, operation of botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise to engage in activity contrary to applicable law.

Data & Privacy

By applying to register a .BBC domain name, or by asking us to maintain or renew a domain name registration, you agree to the applicability of the current version of the Privacy Policy as described at www.bbc.co.uk/privacy/information/policy/.

You agree that BBC's Whois data requirements require you to provide complete, accurate, and current contact details in order to undertake a .BBC domain name registration; you also agree that, pursuant to its contractual obligations to ICANN or for any reason determined appropriate in its sole discretion, BBC may publish these contact details or provide them to third parties.

You also agree that ICANN may conduct Whois verification and checks on a statistically significant basis to identify registrations with deliberately false, inaccurate or incomplete Whois data at least twice a year which may result in the Registrar contacting you to solicit accurate and complete Whois contact information.

Disputes

All disputes between you and BBC concerning the registration of a .BBC domain name shall be handled according to the terms of the BBC Terms of Service, available at: <http://www.bbc.co.uk/terms> and in accordance with the following principles:

- (i) any dispute shall in the first instance be referred to the BBC Domain Manager for resolution;
- (ii) any appeal from the BBC Domain Manager's decision shall be referred to the BBC Head of Legal for Intellectual Property; and
- (iii) if required a final resolution of any dispute shall be by the BBC's General Counsel.

All disputes between you and a third party concerning that third party's rights shall be handled according to the terms of the UDRP or URS (see Registration Terms & Conditions), court, or other appropriate adjudicatory system.

(i) UDRP

By registering a .BBC domain name, you agree to the applicability of the Uniform Domain Name Dispute Resolution Policy (UDRP); the UDRP policy and rules are located at: www.icann.org/dndr/udrp/policy.htm.

(The remedies available for a successful complaint under the UDRP are cancellation or transfer of the domain name to the UDRP filing complainant. In the event of a UDRP decision concerning a .BBC domain name, ordering transfer of a domain name to a UDRP complainant, any such transfer can only occur if the prevailing UDRP complainant meets all requirements of the .BBC Domain Policy including as to eligibility. In the event a prevailing UDRP complainant does not meet the conditions of the .BBC Domain Policy including as to eligibility, notwithstanding any UDRP transfer order, BBC will cancel the subject domain name registration. At BBC's sole discretion, such cancelled domain name registration may be placed on a "reserved" list, or may be made available for registration under the terms of the .BBC Domain Policy.)

(ii) URS

By registering a .BBC domain name, you agree to the applicability of the Uniform Rapid Suspension system (URS); the URS policy and rules are located at: <http://newgtlds.icann.org/en/applicants/urs>.
