#### FROGANS TLD REGISTRATION POLICY

## Pursuant to OP3FT's answers to question 18 of the .frogans TLD application, especially sections 18.3 and 18.4:

The OP3FT uses the .frogans TLD with the aim of ensuring the security, stability and reliability of the Frogans layer for the benefit of all Internet users.

The OP3FT uses .frogans TLD domain names for addressing the computers that are dedicated to the functioning of the Frogans layer on the Internet.

These computers are to be used, for example:

- for the distribution of the free software application that allows all Internet users to navigate Frogans sites (Frogans Player);
- for the resolution of Frogans addresses from anywhere on the Internet.

This use of the .frogans TLD is inspired by the use of the .net TLD, as specified by Jon Postel in RFC 1591 (March 1994).

The OP3FT will not use .frogans TLD domain names for naming Frogans sites. Indeed, the global addressing system of the Frogans layer (Frogans Network System) relies on Frogans addresses, whose specific and simple pattern (network-name\*site-name) is not related to the Uniform Resource Identifier (URI) scheme.

The use of the .frogans TLD adheres to ICANN's principles for keeping the Internet secure, stable and interoperable, while encouraging more innovation on the Internet.

With respect to the OP3FT's public-interest mission and in consideration of the use of the .frogans TLD specified above, the registration policy for the .frogans TLD is as follows:

- The OP3FT will always be the sole and unique holder of domain names in the .frogans TLD registry;
- The OP3FT will never commercialize any domain names in the .frogans TLD registry to third parties;
- The maximum number of domain names in the .frogans TLD registry will be 1,000.

The registration policy for the .frogans TLD will be compliant with all applicable policies required by ICANN.
