# **TLD Registration Polices**

#### 1. .GODADDY TLD Mission and Purpose

The mission or purpose of the .GODADDY gTLD is strictly for branding protection and internal use. The gTLD .GODADDY will give visitors to any .GODADDY site the assurance that they are truly dealing with GoDaddy and not an imposter. Additionally, visitors will be further exposed to the GoDaddy brand and the quality products and services offered.

### 2. Registration Eligibility

- a. Registrations in the .GODADDY TLD, and control of the DNS records associated with such registrations, will be limited to Registry Operator, its Affiliates, and qualifying Trademark Licensees as defined in, and in accordance with, Specification 13 of the Registry Agreement ("Specification 13") where applicable.
- b. Additionally, registrations will be used by Registry Operator in the conduct of one or more of its business that are unrelated to the provision of TLD Registry Services, such as web site creation, the promotion of GoDaddybranded services and improvement of brand protection and brand recognition.

#### 3. Domain Name Allocation

- a. Domain names will be allocated solely to Registry Operator and its affiliates within the .GODADDY TLD in accordance with ICANN policy.
- b. Registrations in the .GODADDY TLD will be allocated and maintained through the GoDaddy.com, LLC (IANA #146) registrar.

#### 4. Reserved Names

a. Registry Operator reserves two-character labels, country and territory names and other labels in accordance with ICANN policies and reserves the right to revise this policy from time to time to ensure compliance with future ICANN policies.
