Amendment No. 1 to Registry Agreement

The Internet Corporation for Assigned Names and Numbers and Fundación Bancaria Caixa d'Estalvis i Pensions de Barcelona, "la Caixa" agree, effective as of 07 December 2015 ("Amendment No. 1 Effective Date") that the modification set forth below is made to the **.lacaixa** Registry Agreement, dated 09 January 2014, between the parties ("Agreement").

WHEREAS, Fundación Bancaria Caixa d'Estalvis i Pensions de Barcelona, "la Caixa", Registry Operator represented to ICANN that it had legally changed its name from Caixa d'Estalvis i Pensions de Barcelona, a caixa d'estalvis (savings bank) formed under the laws of Catalonia, Spain, to Fundación Bancaria Caixa d'Estalvis i Pensions de Barcelona, "la Caixa";

WHEREAS, ICANN has confirmed that Fundación Bancaria Caixa d'Estalvis i Pensions de Barcelona, "la Caixa" is the new name of Registry Operator and that Registry Operator has not assigned any of its rights or obligations under the Agreement in connection therewith;

WHEREAS, Section 7.6(i) of the Agreement allows the parties to bilaterally amend the Agreement in writing signed by both parties; and

NOW, THEREFORE, the parties intending to be legally bound agree as follows:

- 1. All references to "Caixa D'estalvis i Pensions De Barcelona" in the Agreement are hereby stricken and replaced with "Fundación Bancaria Caixa d'Estalvis i Pensions de Barcelona, "la Caixa"".
- 2. Registry Operator represents to ICANN that it has not assigned any of its rights or obligations under the Agreement in connection with the change of its name and that Registry Operator is currently in compliance with the Agreement.
- 3. Except as set forth in Section 1 of this Amendment, the current terms and conditions of the Agreement will remain in full force and effect.
- 4. This Amendment shall inure to the benefit of and be binding upon the parties hereto and their respective successors, trustees, transferees and assigns.
- 5. This Amendment may be executed in counterparts, each of which shall be deemed an original, and all of such counterparts taken together shall constitute one and the same instrument.
- 6. All capitalized terms used in this Amendment but not defined herein will have the meaning given to them in the Agreement.
