

## **Amendment No. 1 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and Charleston Road Registry, Inc., agree, effective as of \_\_\_\_\_ (“Amendment No. 1 Effective Date”), that the modification set forth below is made to the 04 June 2015 **.MOTO** Registry Agreement between the parties (“Agreement”).
