RE: Request for Exemption from Registry Operator Code of Conduct

SPIEGEL-Verlag Rudolf Augstein GmbH & Co. KG ("Registry Operator"), in connection with the execution of the Registry Agreement for the .SPIEGEL TLD (the "Registry Agreement"), hereby requests an exemption from the obligations of the Registry Operator Code of Conduct set forth in Specification 9 to the Registry Agreement (the "Code of Conduct"). Pursuant to such request, Registry Operator confirms that each of the following statements is true and correct (collectively, referred to as the "Statements"):

- 1. All domain name registrations in the TLD shall be registered to, and maintained by, Registry Operator for the exclusive use of Registry Operator or its Affiliates (as defined in the Registry Agreement);
- 2. Registry Operator shall not sell, distribute or transfer control or use of any registrations in the TLD to any third party that is not an Affiliate of Registry Operator; and
- 3. Application of the Code of Conduct to the TLD is not necessary to protect the public interest for the following reasons:

The TLD ultimately is intended to function as Spiegel's online centralized information platform. It is intended to function with leading-edge technologies to ensure a trustworthy and positive user experience. Spiegel intends to use advanced technical and policy measures to ensure the security and reliability of online transactions and communications taking place on domains within the TLD, and to ensure that domain names in the TLD are only used for authorized purposes.

Naturally, as Spiegel will be the registrant of all domain names within the space, it will have full control over the content displayed on ".SPIEGEL" websites. Spiegel intends to provide a safe and trustworthy Internet space, enhancing user experience by mitigating security-associated risks.

The TLD is designed to reinforce the corporate ideals of the Spiegel company, and to provide an online forum by which the company may communicate with its broad-ranging network of readers, customers and casual Internet visitors. Therefore, domains within the TLD will only be used for purposes authorized by Spiegel. Domain usage guidelines will be implemented and enforced to constantly

ensure the integrity of users' ".SPIEGEL" experience and the reputation of the TLD.

All domain name registrations within the ".SPIEGEL" space shall be held by Spiegel. Spiegel may, in its sole discretion, elect to license domain name registrations to affiliated entities, such as affiliated companies or journalists, to further the business interests of the company. All domain name registrations and license agreements shall incorporate the usage requirements set out in the Domain Name Registration and Usage Policy for ".SPIEGEL," a draft version of which is provided at the end of this section. Spiegel intends that no domain name in the ".SPIEGEL" space shall be used in a manner which:

- infringes any other third parties rights
- is in breach with any applicable laws, government rules or requirements

or for the purposes of:

- undertaking any illegal or fraudulent actions, including spam or phishing activities, or
- defaming Spiegel or its businesses, affiliates, employees, etc.

The ".SPIEGEL" domain space shall be used for the benefit of the Spiegel company. Spiegel will have the right to revoke any domain name license agreement should it deem such action appropriate for the benefit of Spiegel and its business interests.

The content and use of all registered ".SPIEGEL" domain names will be monitored by Spiegel on an ongoing basis, and compliance with the contractual restrictions and guidelines will be enforced. Violations of any restrictions, guidelines or other contractual conditions may result in termination of the relevant domain name license.

Registry Operator represents that the registration policies attached hereto as <u>Exhibit A</u> are a true and correct copy of the Registry Operator's registration policies for the TLD. Registry Operator agrees that if Registry Operator makes any changes to its registration policies (whether before or after an exemption has been granted), it will promptly provide ICANN with a revised set of registration policies.

Registry Operator acknowledges and agrees that in the event that any of the foregoing Statements becomes untrue (including after ICANN has granted an exemption pursuant to this exemption request), any Code of Conduct exemption granted by ICANN to Registry Operator for the TLD shall immediately expire, and Registry Operator shall (i) immediately notify ICANN specifying in reasonable detail the circumstances causing any of the Statements to be untrue and (ii) immediately comply with the Code of Conduct.

Registry Operator further acknowledges and agrees that ICANN may revoke this exemption at

any time based upon evidence reasonably satisfactory to ICANN that the Statements have become untrue. In the event that ICANN provides notice that it has revoked this exemption, Registry Operator shall immediately comply with the Code of Conduct.

EXHIBIT A

Domain Name Registration and Use Policy for ".SPIEGEL"

I. General principles

1. Purpose

The ".SPIEGEL" Top Level Domain ("TLD") established by and for the use of SPIEGEL-Verlag Rudolf Augstein GmbH & Co. KG (SPIEGEL-Verlag), the Registry Operator for the TLD space. The Registry Operator reserves the sole and exclusive right to make any changes to domain name registrations within the .SPIEGEL (including the cancellation, transfer, deletion or suspension of any such domains) where it determines that the registration in question is in violations of the terms and conditions contained herein, or is contrary to the best interests of SPIEGEL-Verlag.

This Policy is intended to be updated and revised regularly to reflect the needs of SPIEGEL-Verlag and its TLD. The current version of this Policy will be made publicly available at: [insert website when determined].

The registration of domain names within the ".SPIEGEL" TLD shall be restricted to SPIEGEL-Verlag itself, thus following a single-registrant model. SPIEGEL-Verlag may, in its sole discretion, elect to license domain name registrations to affiliated entities, such as affiliated companies or journalists, and other affiliated entities.

2. Registration Policy

As indicated above, the ".SPIEGEL" follows a single-registrant model. Thus, SPIEGEL-Verlag Rudolf Augstein GmbH & Co. KG shall be the only entity eligible to register domain names within the ".SPIEGEL" TLD.

3. Licensing of domain name registrations

SPIEGEL-Verlag Rudolf Augstein GmbH & Co. KG may, in its sole discretion, elect to license domain name registrations within the ".SPIEGEL" space to, inter alia, appropriate corporate divisions, subsidiaries, and other affiliated entities. In all cases, however, SPIEGEL-Verlag will remain the registrant of record for all domain name registrations within the TLD, and shall retain the authority to modify or terminate such registrations at any time via the concerned registrar.

II. Domain Allocation Rules

3. String Requirements and Reserved Names

String Requirements

Second-Level Domain names within the TLD must only include hyphens in the third and fourth

position if they represent valid internationalized domain names in their ASCII encoding (for example "xn--ndk061n"), and must otherwise comply with any other applicable ICANN requirements.

Reserved Names

At all times SPIEGEL-Verlag Rudolf Augstein GmbH & Co. KG will reserve names from registration in accordance with Specification 5 of the Registry Agreement.

However, SPIEGEL-Verlag may propose the release of these reservations, subject to review by ICANN's Governmental Advisory Committee and approval by ICANN.

III. Acceptable Usage Guidelines for ".SPIEGEL" Domain Names

6. Acceptable Use

The ".SPIEGEL" space is intended to function as the SPIEGEL-Verlag's online corporate branding platform, and as such the registrations therein should generally support the goals and mission of the organization.

Accordingly, no registered .SPIEGEL domain name may be used in a manner which:

- infringes any other third parties rights
- is in breach with any applicable laws, government rules or requirements

or for the purposes of:

- undertaking any illegal or fraudulent actions, including spam or phishing activities, or
- defaming SPIEGEL-Verlag or its defaming Spiegel or its businesses, affiliates, employees, etc.

SPIEGEL-Verlag will monitor the use of all domain names registered in the ".SPIEGEL" space to ensure that the content displayed thereon is in the best interests of the company and its business endeavors. Failure to comply with the terms and conditions set out in this Registration agreement will result in the immediate cancellation, transfer, deletion or suspension of a registered .SPIEGEL domain. The Registry Operator reserves the right to make any necessary changes to a domain name registration in the event of breach of the provisions herein established.

IV. Dispute Resolution Policies

The registrant of any .SPIEGEL domain name hereby agrees to be bound to the provisions of the following dispute resolution Policies in force within the .SPIEGEL space:

7. Uniform Domain Name Dispute Resolution Policy ("UDRP")

The Uniform Domain Name Dispute Resolution Policy ("UDRP") shall apply to any challenges to registered domain names on the grounds that: 1) such domain names are identical or confusingly similar to a trademark in which the complainant has rights, 2) the registrant lacks rights or legitimate interests in the domain name, and 3) the domain name has been registered and used in bad faith. 8. Uniform Rapid Suspension System ("URS")

The Uniform Rapid Suspension System ("URS") shall apply to any challenges to registered domain names on the grounds that: 1) such domain names are identical or confusingly similar to a trademark in which the complainant has rights, 2) the registrant lacks rights or legitimate interests in the domain name, and 3) the domain name has been registered and used in bad faith. 9. Trademark Post-Delegation Dispute Resolution Procedure (Trademark PDDRP)

The Registry Operator for ".SPIEGEL" shall agree to be bound by the Trademark Post-Delegation Dispute Resolution Procedure (Trademark PDDRP). The Trademark PDDRP applies to challenges by trademark holders claiming that one or more of its marks have been infringed, and thereby the trademark holder has been harmed, by the registry operator's manner of operation or use of the gTLD. 10. The Registry Operator for ".SPIEGEL" will comply with all dispute resolution mechanisms as defined in the registry agreement Specification 7 article 2, and as revised from time to time by ICANN consensus policies and procedures. Registrant of .SPIEGEL domain names agrees to be bound by all applicable domain name dispute policies, as outlined in this Registration Agreement.

These dispute mechanisms include, but are not limited to:

- the Trademark Post-Delegation Dispute Resolution Procedure ("PDDRP");
- the Uniform Rapid Suspension system ("URS");
- the Public Interest Commitment Dispute Resolution Procedure (PICDRP);
- the Uniform Domain Name Dispute Resolution Policy ("UDRP").
