RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Vladimir Shadrunov,

Please be advised that as of 6 February 2018, Fan Domains Ltd. ("Fan Domains") is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 19 March 2015 ("RAA"). This breach results from:

- 1. Fan Domains' failure to maintain and make available to ICANN registration data and records relating to dealings with the Registered Name Holder ("RNH") of the domain name explicitly and solution of the RAA; and sol
- 2. Fan Domains' failure to permit the Registrant at Expiration ("RAE") to renew an expired domain name registration, as required by Section 2.2.5 of the Expired Registration Recovery Policy ("ERRP").

Please refer to the attachment for details regarding this breach.

Additional Concerns

On 5 February 2018, ICANN issued Fan Domains a notice of breach which addresses additional items of noncompliance previously identified.

ICANN requests that Fan Domains cure these breaches by 27 February 2018, 21 business days from the date of this letter, by taking the following actions:

 Provide records demonstrating that Fan Domains permitted the RAE to renew the expired domain name <livemusic.fans>. This includes (a) copies of the time stamped renewal notices sent to the Registered Name Holder ("RNH") by your registrar (or reseller if applicable), (b) copies of any other written communications between your registrar (or reseller if applicable) and the RNH and RAE, and (c) confirmation that the



steps taken to resolve this matter will also apply to all existing and future domain name renewals; and

2. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that Fan Domains will timely respond to ICANN compliance matters.

If Fan Domains fails to timely cure the breaches and provide the information requested by 27 February 2018, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to retain registered name holder and registration data and failure to make such data available for inspection and copying

Sections 3.4.2 and 3.4.3 of the RAA requires registrars to maintain RNH and registration data, and to make those records available to ICANN upon reasonable notice. Fan Domains' failure to provide the requested registration records and data related to the domain name elivemusic.fans> is a breach of Sections 3.4.2 and 3.4.3 of the RAA.

Failure to allow RAE to renew expired registration

Section 2.2.5 of the ERRP requires registrars to permit the RAE to renew expired domain name registrations. Fan Domains' failure to allow the RAE to renew the expired registration for elivemusic.fans> is a breach of Section 2.2.5 of the ERRP.
