Dear Danilo Bettini,

Please be advised that as of 10 April 2018, Asiamix Digital Limited ("Asiamix Digital") is in breach of its Registry Agreements with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 6 March 2014 for the top-level domain ("TLD") fan and 7 November 2014 for the TLD fans ("RAs"). This breach result from:

1. Asiamix Digital's failure to timely pay past due fees, as required by Article 6 of the RAs.

The email address for Asiamix Digital's Legal Contact is not functioning.


ICANN requests that Asiamix Digital cure these breaches by 10 May 2018, 30 days from the date of this letter, by taking the following actions:

1. Provide ICANN with the corrective and preventative action(s) that Asiamix Digital will take, with implementation date(s), to ensure:
 - a. timely payment of fees to ICANN;
 - b. timely and complete response to ICANN Contractual Compliance matters; and
 - c. Asiamix Digital's contact information with ICANN is up to date and functioning; and
2. Pay all past and currently due fees.

If Asiamix Digital fails to timely cure the breaches and provide the information requested by 10 May 2018, ICANN may commence the RA termination process.

Failure to pay fees

Article 6 of the RA requires registry operators to pay Registry-Level Fees on a quarterly basis within 30 calendar days following the date of the invoice provided by ICANN. Asiamix Digital owes ICANN past due fees, in breach of Article 6 of the RA.
