Dear ZhengZeng Zhou,

Please be advised that as of 22 May 2018, Beijing Midwest Taian Technology Services Ltd.'s ("Beijing Midwest Taian") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 30 August 2013 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 21 June 2018, 30 calendar days from the date of this notice.

The termination is due to Beijing Midwest Taian's failure to timely cure the breaches by 21 May 2018 as set forth in ICANN's notice of breach of RAA dated 30 April 2018. As of 22 May 2018, the following breaches remain:

- 1. Beijing Midwest Taian's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA;
- Beijing Midwest Taian's failure to provide an interactive webpage and a port 43 Whois service providing free public query-based access to up-to-date data concerning all active registered names sponsored by Beijing Midwest Taian for each top-level domain ("TLD") in which it is accredited, as required by Section 3.3.1 of the RAA;
- 3. Beijing Midwest Taian's failure to escrow gTLD registration data, as required by Section 3.6 of the RAA;
- Beijing Midwest Taian's failure to display Beijing Midwest Taian's deletion and autorenewal policies on Beijing Midwest Taian's website, as required by Section 3.7.5.5 of the RAA;
- Beijing Midwest Taian's failure to publish on Beijing Midwest Taian's website(s) and/or provide a link on its website to the Registrants' Benefits and Responsibilities Specification, as required by Section 3.7.10 of the RAA;



- 6. Beijing Midwest Taian's failure to provide current documentation demonstrating Beijing Midwest Taian is in good standing, as required by Section 3.17 and Section 6 of the Registrar Information Specification ("RIS") of the RAA;
- 7. Beijing Midwest Taian's failure to publish its correspondence address on Beijing Midwest Taian's website, as required by Section 3.17 and Section 7 of the RIS of the RAA;
- 8. Beijing Midwest Taian's failure to publish the full name and position of all officers of the registrar on Beijing Midwest Taian's website, as required by Section 3.17 of the RAA and Section 17 of the RIS of the RAA;
- Beijing Midwest Taian's failure to publish an email address to receive abuse reports on the home page of Beijing Midwest Taian's website, as required by Section 3.18.1 of the RAA;
- 10. Beijing Midwest Taian's failure to publish on its website a description of Beijing Midwest Taian' procedures for the receipt, handling and tracking of abuse reports, as required by Section 3.18.3 of the RAA;
- 11. Beijing Midwest Taian's failure to clearly display on Beijing Midwest Taian's website, and include a link in its registration agreement to, its renewal fees, post-expiration renewal fees (if different) and redemption/restore fees, as required by Section 4.1 of the Expired Registration Recovery Policy ("ERRP"); and
- 12. Beijing Midwest Taian's failure to provide on Beijing Midwest Taian's website and in its registration agreement, a description of the methods used to deliver pre- and post-expiration notifications, as required by Section 4.2 of the ERRP.

Additionally, Beijing Midwest Taian has failed to display domain name data in the specified response format, as required by Section 1.4 of the Whois Specification, Clarifications and AWIP or provide ICANN with the corrective and preventative action(s) that Beijing Midwest Taian will take, with implementation date(s), to ensure: (a) timely and complete response to ICANN Contractual Compliance matters, (b) Beijing Midwest Taian' contact information is up to date and (c) timely payment of fees.

Beijing Midwest Taian is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 21 June 2018. Please remove all ICANN trademarks, name and logo from Beijing Midwest Taian's website and business materials that have been licensed to Beijing Midwest Taian under the terms of that Specification by 21 June 2018.



Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by Beijing Midwest Taian.

ICANN will follow the <u>De-Accredited Registrar Transition Procedure</u> ("Procedure"). Consistent with the Procedure, please designate a bulk transfer recipient by 29 May 2018 and inform ICANN's Registrar Liaison Team at <u>RegTransition@icann.org</u>.

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Beijing Midwest Taian has current and past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
