Dear Tian Lei Zhang,

Please be advised that as of 27 July 2018, Tong Ji Ming Lian (Beijing) Technology Corporation Ltd. (Trename) (“Trename”) is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 10 August 2015 (“RAA”). This breach results from:

1. Trename’s failure to escrow gTLD registration data, as required by Section 3.6 of the RAA.

Please refer to the attachment for details regarding this breach.

In addition, Trename has been deemed noncompliant in the following areas:

1. Trename’s failure to display the correct ICANN logo on Trename’s website, as required by the Logo License Specification of the RAA; and
2. Trename’s failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

ICANN requests that Trename cure these breaches by 17 August 2018, 21 days from the date of this letter, by taking the following actions:

1. Deposit gTLD registration data on a weekly basis to an approved escrow agent and ensure that the deposits meet the required specifications;
2. Display the correct ICANN logo on Trename’s website in accordance with the Logo License Specification of the RAA or remove the ICANN logo from Trename’s website;
3. Pay all past due accreditation fees; and

4. Provide ICANN with the corrective and preventative action(s) that Trename will take, with implementation date(s), to ensure:
 - a. timely and complete response to ICANN Contractual Compliance matters; and
 - b. timely payment of fees to ICANN.

If Trename fails to timely cure the breaches and provide the information requested by 17 August 2018, ICANN may commence the RAA termination process.

ATTACHMENT

Failure to escrow gTLD registration data

Section 3.6 of the RAA requires registrars to submit an electronic copy of the data described in Sections 3.4.1.2 through 3.4.1.5 of the RAA to ICANN or, at the registrar's expense, to a reputable escrow agent mutually approved by the registrar and ICANN. Registrars shall submit the data on a schedule, under the terms, and in a format specified by ICANN. Trename's failure to deposit gTLD registration data with an approved escrow agent under the required schedule and terms is a breach of Section 3.6 of the RAA.

Failure to display correct ICANN-Accredited Registrar logo

The Logo License Specification of the RAA requires registrars, if displaying the ICANN-Accredited Registrar logo, to use the logo displayed in the specification. Trename's use of an unapproved logo is a breach of the Logo License Specification of the RAA.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Trename owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA.
