Please be advised that as of 8 March 2019, Webveloper Inc. (“Webveloper”) is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 19 September 2017 (“RAA”). This breach results from:

1. Webveloper’s failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additional Concerns

Webveloper’s contact information with ICANN is out of date.

ICANN requests that Webveloper cure these breaches by 29 March 2019, 21 days from the date of this letter, by taking the following actions:

1. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure:
 - a. Webveloper’s contact information with ICANN is up to date;
 - b. timely and complete responses to ICANN Contractual Compliance matters; and
 - c. timely payment of ICANN fees; and
2. Pay all past due accreditation fees.

If Webveloper fails to timely cure the breaches and provide the information requested by 29 March 2019, ICANN may commence the RAA termination process.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Webveloper owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA.
