Dear Louis Brion and Neil Bhasin:

Please be advised that as of 3 April 2019, Webveloper Inc.'s ("Webveloper") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 19 September 2017 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 19 April 2019, 16 calendar days from the date of this notice.

The termination is due to Webveloper's failure to timely cure the breach by 29 March 2019 as set forth in ICANN's notice of breach of RAA dated 8 March 2019. As of 3 April 2019, the following breach remains:

1. Webveloper's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additionally, Webveloper has failed to:

- 1. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure:
  - a. Webveloper's contact information with ICANN is up to date;
  - b. timely and complete responses to ICANN Contractual Compliance matters; and
  - c. timely payment of ICANN fees.

Webveloper is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 19 April 2019. Please remove all ICANN trademarks, name and logo from Webveloper's website and business materials that have been licensed to Webveloper under the terms of that Specification by 19 April 2019.

## **Domain Name Transition Process**

No domain names are currently managed by Webveloper. Therefore, ICANN does not need to follow the <u>De-Accredited Registrar Transition Procedure</u> ("Procedure").

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Webveloper has current and past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN Accounting.
