## Work Items Signing the root zone name server data

Duane Wessels reviewed the status of the signing root name server data document. Tim April recently submitted editorial changes to the google document prior to the meeting. RZERC members agreed they would like the chance to share the document with their respective constituencies prior to voting on the final document.

# Protecting root zone content
