Dear Dave Munson,

Please be advised that as of 2 January 2018, Rethem Hosting LLC's ("Rethem Hosting") 2009 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 15 February 2013 ("RAA") is terminated pursuant to Section 5.3.4 of the RAA. The termination shall become effective 1 February 2018, 30 calendar days from the date of this notice.

The termination is due to Rethem Hosting's failure to timely cure the breaches by 28 December 2017 as set forth in ICANN's notice of breach of RAA dated 6 December 2017. As of 2 January 2018, the following breaches remain:

1. Rethem Hosting's failure to take reasonable steps to investigate and correct claimed Whois inaccuracies regarding the domain name <fotogrey.com>, as required by Section 3.7.8 of the RAA;
2. Rethem Hosting's failure to maintain and make available to ICANN registration data and records relating to dealings with the Registered Name Holder ("RNH") of the domain name <fotogrey.com>, as required by Sections 3.4.2 and 3.4.3 of the RAA;
3. Rethem Hosting's failure to provide an interactive webpage Whois service providing free public query-based access to up-to-date data concerning all active registered names sponsored by Rethem Hosting for each top-level domain ("TLD") in which it is accredited, as required by Section 3.3.1 of the RAA;
4. Rethem Hosting's failure to provide a link on Rethem Hosting's website to ICANN's registrant rights and responsibilities webpage, as required by Section 3.15 of the RAA; and

5. Rethem Hosting's failure to clearly display on Rethem Hosting's website, and include a link in its registration agreement to, its renewal fees, post-expiration renewal fees (if different) and redemption/restore fees, as required by Section 4.1 of the Expired Registration Recovery Policy ("ERRP").

Additionally, Rethem Hosting has failed to confirm Rethem Hosting's expiration reminder notice policy complies with the requirements of the ERRP and publish a policy that is consistent with the ERRP or remove the portions of Rethem Hosting's policy that are inconsistent with the expiration reminder notice requirements of the ERRP.

Please see the chronology below for additional details.

Rethem Hosting is further advised that the logo license granted in the Logo License Appendix to the RAA is revoked as of 1 February 2018. Please remove all ICANN trademarks, name and logo from Rethem Hosting's website and business materials that have been licensed to Rethem Hosting under the terms of that Appendix by 1 February 2018.

Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by Rethem Hosting.

ICANN will follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure"). Consistent with the Procedure, please designate a bulk transfer recipient by 9 January 2018 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.6 Resolution of Disputes Under this Agreement, and 5.7 Limitations on Monetary Remedies for Violations of this Agreement.

Rethem Hosting has past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
